- 1.1.1 Bidder should have executed at least one job of Engineering and Project Management Consultancy services for implementation of City Gas Distribution Project (i.e. PNG (Piped Natural Gas) Work in Commercial & Industrial Sectors and CNG (Compressed Natural Gas) to Automobiles Consumers) having Steel Pipe Network of minimum 05 kms in a single work order during any of the preceding 7 years.

# **Definition of Similar Work**

- 1.3 "Engineering & Project Management Consultancy (EPMC) Services for City Gas Distribution Industry for with Detailed Design & Engineering of Steel and MDPE Networks including, Procurement and Tendering assistance for the major items/services required for CGD Network, site supervision and project management, with / without all other associated designing and services."
- 1.4 The bidders to note that to meet the following requirement:
- 1.4.1 Sublet jobs shall not be considered for similar work.
- 1.4.2 For similar job purpose, a Job completed through a single order or multiple purchase orders shall only be considered.
- 1.4.3 Bidder must submit copy(s) of work order/ contract including detailed scope of work along with its completion certificate/ execution certificate from the concerned authority duly certified/ attested by the Chartered Engineer and Notary Public with legible stamp along with bid to meet the above technical criteria with latest date.
- 1.4.4 In case of composite works/ lump sum turnkey jobs, the executed (other items/works outside the similar work requirement), to arrive at value of similar works mentioned in the tender, the required break up shall be given by the party with notarization along with the unpriced bid itself. In absence of work breakup from bidder, VGL may extend a single opportunity to bidder for submitting the details. In case of no response or requisite details not provided by the bidder, VGL shall arrive at the break up on their own and such calculation shall be final and binding on the bidder. - 1.4.5 Post submission of Bids, Bidder shall not be allowed to furnish any new experience details not included in experience list furnished in their Bid. Bidders are requested to submit all qualification details along with relevant supporting authenticated documents at the first instance itself. No additional document pertaining to technical/financial BEC shall be accepted post due date of the tender. However, VGL also reserves the right to seek clarification/document with reference to originally submitted document for completing evaluation, if so required.

## Note:

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for

## Financial Criteria (as a single bidder)

The Average Annual Turnover of the bidder should be minimum of ₹ 46,25,128.00/- during 03 Preceding Financial Years.

The Net Worth of the Bidder should be Positive as per the Last Audited Financial Statement.

The Working Capital of the Bidder should have a minimum of ₹ 9,25,025.00/- as per the Last Audited Financial Year.

Note: The 03 Preceding Financial Year shall be F.Y. 2021-22, F.Y. 2022-23 & F.Y. 2023-24.

<u>Annual Turnover</u> – In case the tenders have the bid closing date up to 31st September (or as amended from time to time by the Government) of the relevant financial year, and audited financial results of immediate 3 preceding financial years are not available, the bidder has the option to submit the audited financial results of the 3 years immediately before that. ### **Financial Criteria of BEC**

Bidder shall submit "Details of financial capability of Bidder" in the prescribed format (F-15) duly signed and stamped by a chartered accountant/ Certified Public Accountant (CPA).

Further, a copy of audited annual financial statements submitted in the bid shall be duly certified/attested by Notary Public with a legible stamp

Apart from the above, the Bidder must submit all other relevant documents/ information as specified in the Scope of Work/ SCC for Technical Evaluation of a bid or specified elsewhere in the Tender Document, towards proof of its responsiveness.
