For Dealer/ Distributor: Bidder must submit the copy of Authorized Dealer/ Distributor/ Certificate with validity from the Manufacturer of Domestic Regulators along with documentary proof of the manufacturing company being a manufacturer of Domestic Regulators duly certified/attested by notary public with legible stamp

2. The bidder must have supplied a minimum of **9,000 Nos.** of Domestic Regulators in a single order/ contract in a year to an established Natural Gas Distribution Company in any of previous 7 years to be reckoned from the final bid closing date.

DOCUMENTS REQUIRED

Bidder must submit copy(ies) of Purchase order/ contract along with its completion certificate/ execution certificate from the concerned authority or IRN, Tax Invoices, LR Copies, E-way Bills and relevant documents stating the completion of the order; duly certified/ attested by **Chartered Engineer & Notary Public with Legible Stamp** along with bid in respect of their meeting the above technical criteria.

B. FINANCIAL CRITERIA (AS A SINGLE BIDDER)

1. **Annual Turn Over** of the bidder should be a minimum of **Rs. 63.72 Lakhs**, in any one of the preceding three financial years.
2. **Net worth** of the bidder should be **Positive** as per the last audited financial statement.
3. **Working Capital** of the Bidder should be a minimum of **Rs. 25.49 Lakhs** as per last audited financial year.

DOCUMENTS REQUIRED

The bidder shall submit “Details of Financial Capability of bidder” in prescribed format as enclosed duly signed and stamped by **Chartered Accountant and Notary Public with Legible Stamp**.

Further, copies of audited annual financial statements of last three years submitted in bid shall be duly certified and attested by notary public with legible stamp with latest date. Documents to be certified by CA & Notary both and No photo copy of attestation/certification of CA & Notary is to be considered.

C. EVALUATION METHODOLOGY

1. Evaluation shall be done on individual item wise L1 basis into consideration for evaluation and comparison purpose.
2. Methodology for Evaluation and Award shall also include price evaluation based on individual item wise lowest evaluated price (L-1) basis.
