Bid Evaluation Criteria (BEC)

1. <u>Technical Criteria</u> (As A Single Bidder):

The bidder must have completed or executed work orders or contracts for "similar works" as specified below:

Bidder must have Experience of at least three "similar work" orders/ contracts having a minimum order value of ₹ 90.09 Lakh for a period of 01 year duration in previous 7 years to be reckoned from the final bid closing date.

OR

Bidder must have Experience of at least two "similar work" orders/ contracts having a minimum order value of ₹ 1.09 Cr for a period of 01 year duration in previous 7 years to be reckoned from the final bid closing date.

OR

Bidder must have Experience of at least one "similar work" order/ contract having a minimum order value of ₹ 1.81 Cr for a period of 01 year duration in previous 7 years to be reckoned from the final bid closing date.

"Similar Works" shall mean experience of completion/ execution of Operation and Maintenance of PE Lines and PNG Connections of a whole GA area including Departmental works in CGD Network.



In Support of BEC, bidder must submit copy(s) of Work Order/ Contract including detailed scope of work along with its completion/ execution certificate from the concerned authority, duly certified by the Chartered Engineer and Notary Public with legible stamp along with the bid to meet the above technical criteria.

Note:

- **2. Financial Criteria** (As A Single Bidder):
- 2.1 The Average Annual Turnover of the bidder should be minimum of ₹ 1,81,96,804.00/- during 03 Preceding Financial Years.
- 2.2 The Net Worth of the Bidder should be Positive as per the Last Audited Financial Statement.
- 2.3 The Working Capital of the Bidder should have a minimum of ₹ 36,39,360.00/- as per the Last Audited Financial Year.

Note: The 03 Preceding Financial Year shall be F.Y. 2022-23, F.Y. 2023-24 & F.Y. 2024-25.

<u>Annual Turnover</u> – In case the tenders have the bid closing date up to 31st September (or as amended from time to time by the Government) of the relevant financial year, and audited financial results of immediate 3 preceding financial years are not available, the bidder has the option to submit the audited financial results of the 3 years immediately before that. Wherever the closing date of the bid is after 31st September (or as amended from time to time by the Government) of the relevant financial year, the bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years.

Net worth and Working Capital —In case the tenders having the bid closing date upto 31st September (or as amended from time to time by the Government) of the relevant financial year, and audited financial results of the immediately preceding financial year are not available, in such a case the audited financial results of the year immediately before that year will be considered as last financial year for Net worth/ Working Capital calculation. Wherever the closing date of the bid is after 31st September (or as amended from time to time by the Government) of the relevant financial year, the bidder has to compulsorily submit the audited financial result for the immediately preceding financial year. If the bidder's working capital is negative or inadequate, the bidder shall submit a letter from their bank having a net worth not less than ₹ 100a crores, confirming the availability of a line of credit for at least the working capital requirement as stated above. The line of credit letter from the bank is to be submitted strictly as per the format of F-14.

Note:

- The documents such as purchase / work order completion / execution certificate, audited balance sheet etc required to be submitted by bidders for establishing that they meet BEC. Any other document requested specific to work/job, should be finalized after proper deliberation by the tender committee and incorporated in the tender document.
- 2. The bidders must submit the completion certificate issued by end user / owner (or their consultant who has been duly authorized by them to issue such certificate) only after completion of work / supply in all aspect. However, in case, main contractor and subcontractor with such end user certificate participates against same tender and seeks qualification based on same job, then main contractor will be preferred over sub-contractor in respect of qualification and accordingly subcontractor even with end user certificate will not be considered qualified.
- 5. The Bids submitted by only such bidders who meet fully the criteria, should be taken up for detailed evaluation. No relaxation is permitted for inclusion of any bidder(s) who do not meet the criteria in entirety, for reasons only to increase the competition.

3. Methodology for Evaluation, Comparison & Award

- 3.1 Evaluation, Comparison and Award shall be done on overall L1 basis (Excl. of GST).
- 3.2 In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in last audited financial year.
