TECHNICAL CRITERIA (as a single bidder)

The bidder should have an experience for providing services of Vehicles to any Govt./ Semi Govt. /PSU/MNC/ Public Limited Company/Pvt. Ltd Company and must have executed at least one single work order/ contract having a minimum order value of **₹ 14.13 Lakhs** for a period of One (01) year duration. Previous Seven (07) years to be reckoned from the final bid closing date.

Bidder must own at least One (01) no. Sedan car (Taxi Permit) registered in the name of the company or the Proprietor/ Partner/ Director on the date of submission of bid. Documentary proof in the form of RC must be submitted duly certified by Notary Public with legible Stamp.

In Support of BEC, bidder must submit, copy(s) of Work Order/ Contract including detailed scope of work along with its completion/ execution certificate from the concern authority duly certified by the **Chartered Engineer and Notary Public** with legible stamp with original attestation along with the bid to meet the above technical criteria.

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.
