#### **BID EVALUATION CRITERIA (BEC)**

#### **TECHNICAL CRITERIA** (as a single bidder)

The bidder must be a manufacturer and have supplied at least 6750 numbers of Natural Gas Meters of type G-1.6 (flow capacity 2.5 m3/hour) or higher (up to G-4.0 - flow capacity 6 m3/hour), in a single order in the previous 7 years reckoned from bid due date. In case the bidder is not a Gas Meter manufacturer, then Bidder must furnish a written agreement from the manufacturer to own complete responsibility for design, QA/QC, after-sales technical support, unconditional guarantee/warranty, postwarranty services and after-sales support to the purchaser and to the bidder. The authority certificate shall be valid up to the completion of the contract in accordance with the bid document.

One manufacturer can quote through one supplier and a supplier shall offer a product of only one manufacturer for a particular type of Meter. The bid shall be liable for rejection in case of a change of the proposed manufacturer after submission of the offer.

Valid Certification of W&M India for the Gas Meters offered by the bidder for supply under this tender must have:

#### For the Gas Meter manufactured in India:

Valid Model approval, valid License for manufacturing, valid License for Dealer and Repair from Legal Metrology Department (W&M) India.

#### For the Gas Meter manufactured Outside India:

Valid Model approval along with valid Certification of registration of importer from Legal Metrology Department (W&M) India. The valid Certification of registration of importer must be in the name of the bidder.

#### **NOTE:**

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.

Copy(s) of Purchase/ Work order including detailed scope of work along with its completion certificate from the concern authority duly certified/ attested by the **Chartered Engineer and Notary Public** with legible stamp with original attestation along with the bid to meet the above technical criteria.

#### FINANCIAL CRITERIA (as a single bidder)

**Annual Turn Over** of the bidder should be a minimum of ₹ 2,73,46,500.00 in any one of the preceding three financial years.

**Net worth** of the bidder should be **positive** as per the last audited financial statement.

Working Capital of the Bidder should be a minimum of ₹ 54,69,300.00 as per last audited financial year..

#### **DOCUMENTS REQUIRED**

The bidder shall submit "Details of Financial Capability of bidder" in prescribed format (F - 16) duly signed and stamped by a **Chartered Accountant**.

Further, copies of audited annual financial statements of last three years submitted in bid shall be duly certified and attested by notary public with legible stamp with latest date. No photo copy of attestation/certification of CA & Notary shall be considered.

#### AUTHENTICATION OF DOCUMENTS TO BE SUBMITTED IN SUPPORT OF BEC

#### **Technical Criteria of BEC**

All documents in support of Technical Criteria of BEC to be furnished by the Bidder shall necessarily be <u>duly certified/ attested by Chartered Engineer and Notary Public with legible stamp</u>.

#### **Financial Criteria of BEC**

Bidder shall submit "Details of financial capability of Bidder" in prescribed format (F-16) duly signed and stamped by a chartered accountant/ Certified Public Accountant (CPA).

Further, copy of audited annual financial statements submitted in bid shall <u>be duly certified/ attested by Notary Public with legible stamp</u>.

Apart from the above, the Bidder must submit all other relevant documents/ information as specified in the Scope of Work/SCC for Technical Evaluation of a bid or specified elsewhere in the Tender Document, towards proof of its responsiveness.

#### <u>CLAUSE REGARDING PROVISION FOR PROCUREMENT FROM A BIDDER SHARES A</u> LAND BORDER WITH INDIA (FOR DETAILS – REFER TO CLAUSE NO. 54 OF ITB)

Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.

For details, the relevant clause of ITB is to be preferred.

## METHODOLOGY FOR EVALUATION, COMPARISION & AWARD EVALUATION & COMPARISION METHODOLOGY

The evaluation shall be done on an Item-wise basis at least cost to the Purchaser. Further, the contract shall be divided among two suppliers in the ratio of 60 (L1): 40 (L2). In order to do so, the L-2 bidder shall be asked to match the total quoted price with that of the L-1 bidder. In case the L-2 bidder does not agree to the same, the opportunity shall be given to the L-3 bidder and so on. In case none of the bidders agrees to match the rates of L-1 bidder, 100% quantity shall be awarded on L-1 bidder."

In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in the last audited financial year.

#### **FOR MSE Bidders**

Purchase preference will be given to MSEs defined in Public Procurement Policy for Micro & Small enterprises (MSEs) order, 2012 DT. 23.03.2012 issued by Ministry of Micro, Small and Medium enterprises and subsequent Orders/Notifications issued by the concerned ministry.

Considering the nature of the job, splitting of quantities will not be possible in this tender and hence the clause for the award of 25 % of the ordered quantity to MSE as per PPP 2012 is not possible. Therefore, MSE quoting within a price band of L1 (other than MSE) + 15%, may be awarded for full/ complete services subject to matching of L1 (lowest) price as per ITB of tender document. In case two or more MSE bidder(s) comes within the price band of L1+15%, the preference to match the L1 rate shall be given in sequence of their inter-se position (L2, L3...and so on).

In case of a tie at the lowest bid (L1) position between two or more bidders, the order/ LOA will be placed on the bidder having higher/ highest turnover in the last audited financial year. (Bidder to submit Audited Financials of F. Y. 2020-21 duly notarized).

**NOTE:** VGL shall not be responsible for any delay in receiving the tenders and reserve the right to accept/ reject any or all tenders without assigning any reason.
