## **BID EVALUATION CRITERIA (BEC)**

### TECHNICAL CRITERIA (as a single bidder)

## PACKAGING/MANUFACTURING CRITERIA

The bidder must be a regular manufacturer of compressor block, packager and supplier of Electric Motor Driven CNG Compressor Package. The bidder shall have the single point responsibility for manufacturing / packaging, supplying, installing and commissioning of 1200 SCMH Electric Motor Driven CNG Compressor Package.

The bidder, in the previous seven (07) years from the due date of submission of bid, shall have designed, engineered, manufactured/ packaged, tested, supplied and commissioned to any CGD firm at least 1 no. CNG Motor Driven compressor package of 1200 SCMH capacity suitable for operation at suction pressure in the range of 14-19 bars, discharge pressure of 250 bars, from the proposed facility of manufacturing & this package should have completed continuous trouble free operation for minimum 8000 HRS without any major break down as on the bid due date. The compressor block proposed in the bid shall be of same make and model as used in this CNG Motor Driven compressor package.

### **EQUIPMENT QUALIFICATION CRITERIA**

The offered Gas Compressor model shall be from the existing regular manufacturing range of the Gas Compressor manufacturer. At least 01 no. Compressors, identical to the proposed offered compressor models in terms of number of stages, number of throws, frame power and process gas (i.e. natural gas) must have been manufactured, tested and supplied to customers, from the proposed manufacturing plant in the previous seven years and must have been individually operating satisfactorily in the field for a period of min 8000 hours without any major break down as on the bid due date.

#### NOTE:

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirement of BEC of this tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for

Copy(s) of Purchase/ Work order including detailed scope of work along with its completion certificate from the concern authority duly certified/ attested by the **Chartered Engineer and Notary Public** with legible stamp with original attestation along with the bid to meet the above technical criteria.

### FINANCIAL CRITERIA (as a single bidder)

**Annual Turn Over** of the bidder should be a minimum of ₹ 1,34,36,267.00 in any one of the preceding three financial years.

**Net worth** of the bidder should be **positive** as per the last audited financial statement.

Working Capital of the Bidder should be a minimum of ₹ 36,43,840.00 as per last audited financial year.

#### **DOCUMENTS REQUIRED**

The bidder shall submit "Details of Financial Capability of bidder" in prescribed format (F - 16) duly signed and stamped by a **Chartered Accountant**.

Further, copies of audited annual financial statements of last three years submitted in bid shall be duly certified and attested by notary public with legible stamp with latest date. No photo copy of attestation/certification of CA & Notary shall be considered.
