## **TECHNICAL CRITERIA** (as a single bidder)

1.1.1 The Bidder shall be the Manufacturer or an Authorized Distributor/ Dealer of Domestic Regulators

#### **DOCUMENTS REQUIRED**

**For Manufacturer:** Bidder must submit valid documentary proof Company Registration Certificate/ ISO Certificate, NSIC Certificate etc evidencing manufacturer of Domestic Regulators duly certified/ attested by notary public with legible stamp

**For Dealer/ Distributor:** Bidder must submit the copy of Authorized Dealer/ Distributor/ Certificate with validity from the Manufacturer of Domestic Regulators along with documentary proof of the manufacturing company being a manufacturer of Domestic Regulators duly certified/attested by notary public with legible stamp

**1.1.2** The bidder must have supplied a minimum of **3,750 Nos.** of Domestic Regulators in a single order/contract in a year to an established Natural Gas Distribution Company in any of previous 7 years to be reckoned from the final bid closing date.

#### NOTE TO BEC-TECHNICAL:

- 1) In case, bidder is executing a rate contract of above nature which is still running and the executed quantity till one day prior to the due date of submission of bid is equal to or more than the minimum required quantity as mentioned above, such experience will also be taken into consideration provided that the bidder has submitted satisfactory execution certificate to this effect issued by the end user / owner / Authorized consultant.
- 2) Job completed by a bidder for its own plant/projects shall not be considered as experience for meeting BEC of the tender. However, jobs completed for Subsidiary/Fellow subsidiary / Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor of the bidder towards payments of statutory tax in support of the job completed for Subsidiary/Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified to meet the above BEC.

All documents in support of Technical Criteria of Bid Evaluation Criteria (BEC) to be furnished by the bidders shall necessarily be duly certified/ attested by Chartered Engineer and Notary public with legible stamp

# FINANCIAL CRITERIA (as a single bidder)

- **1.2.1** Annual Turnover The contractor should have achieved a minimum turnover of ₹ 62,62,850.00 in any one of the preceding 3 (three) financial years.
- **1.2.2 Net worth** of the bidder should be **positive** as per the immediately preceding audited financial results of F.Y. 2020-2021.
- **1.2.3** Working Capital of the Bidder should be a minimum of ₹12,52,570.00 as per last audited financial year.

### **DOCUMENTS REQUIRED**

The bidder shall submit "Details of Financial Capability of bidder" in prescribed format (F - 16) duly signed and stamped by a **Chartered Accountant**.

Further, copies of audited annual financial statements of last three years submitted in bid shall be duly certified and attested by notary public with legible stamp with latest date. No photo copy of attestation/certification of CA & Notary shall be considered.
