1. BID EVALUATION CRITERIA:

1.1 TECHNICAL (AS A SINGLE BIDDER):

- 1. The bidder should be a Designer, Manufacturer and Supplier of CNG Cascades and should have manufacturing facility. Documentary evidence in support of the same along with the CCOE approval of Cylinder/ Cascade is to be submitted along with the bid.
- 2. The bidder must have supplied at least 05 CNG Cascades of minimum cylinder pressure of 250 bar and 3000 Ltrs. or more Water Capacity in any single order within last 7 (seven) years reckoned from bid due date.

However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding Company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice (s) duly certified by Statutory Auditor/ Chartered Accountant of the bidder towards payments of statutory tax in support of the job executed for Subsidiary/ Fellow subsidiary/ Holding company. Such bidders to submit these documents in addition to the documents specified in the bidding document to meet BEC.

1.2 FINANCIAL:

• Annual Turnover

The contractor should have achieved a minimum turnover of Rs. 304.68 lakhs in any one of the preceding 3 (three) financial years.

• Net Worth

Net worth of the bidder must be positive as per last audited financial statement.

• Working Capital

The Bidder should have a minimum working capital of Rs. 60.94 Lakhs as per latest audited financial year.

DOCUMENTS REQUIRED

The bidder shall submit "Details of Financial Capability of bidder" in prescribed format (F - 16) duly signed and stamped by a **Chartered Accountant**.

Further, copies of audited annual financial statements of last three years submitted in bid shall be duly certified and attested by notary public with legible stamp with original attestations.

If the bidder's working capital is inadequate, the bidder should supplement it with a letter from the bidder's bank having net worth not less than Rs. 100 Crores, confirming the availability of the line of credit to cover the inadequacy of working capital required as above strictly in the prescribed format.

NOTE:

- (i) Annual Turnover In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediate 3 preceding financial years are not available, the bidder has an option to submit the audited financial results of the 3 years immediately prior to that. Wherever the closing date of the bid is after 31st December (or as amended from time to time by Government) of the relevant financial year, bidder has to compulsorily submit the audited financial results for the immediate 3 preceding financial years.
- (ii) Net worth and Working Capital In case the tenders having the bid closing date upto 31st December (or as amended from time to time by Government) of the relevant financial year, and audited financial results of immediate preceding financial year is not available, in such a case the audited financial results of the year immediately prior to that year will be considered as last financial year for Net worth/ Working Capital calculation. Wherever the closing date of the bid is after 31st December (or as amended from time
