

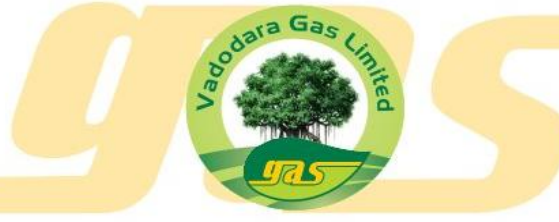

Full payment including GST will be released at the time of processing of invoice for payment, where the GST amount reflects in Form GSTR-2A of VGL. However, in case, where the GST amount doesn't reflect in Form GSTR-2A of VGL, the amount of GST will be released after reflection of GST amount of corresponding invoice in Form GSTR-2A of VGL.
